REACH Statement

Colorcon Limited is committed to meeting the requirements set out in REACH (Registration Evaluation and Authorisation of Chemical) EC 1907/2006.

Colorcon continue to work with suppliers and customers to ensure continued supply of products and do not anticipate any disruption of product supplies to customers.

Registration

Colorcon has pre-registered and will later register all chemical products (phase-in substances) that Colorcon currently produce or import into the EU.

Please note that some Colorcon products are not covered by REACH or are specifically exempt under annex IV or annex V of the legislation.

A standard clause has been added to the contractual agreements with our suppliers requiring that they undertake to comply with REACH.

Substances of Very High Concern

Colorcon confirms that no substances on the list of restricted substances are used in the production of Colorcon products.

Exemptions from REACH

REACH legislation applies to substances, chemical elements or compounds and includes complex substances such as reactions and distillation products.

Preparations which are blends of substances are not covered and as a result many of Colorcon products are exempt. See attached Product list with REACH status.
